



RULES & CONDITIONS

*All Entrants must abide by the following Rules and Conditions for **Manhunt India 2018**. This has to be signed and return to us to signify that you have read these pages. It is the duty of applicant to understand clearly the rules and conditions.

A. ANNOUNCEMENT

1. Must be a natural male and Must be of good health and fitness
2. The Organizing Committee reserves the right to accept or reject any application received.
3. The applicant must be at least 18 years old as at **5 November 2018** and not more than 35 years of age.
4. Applicant should be Minimum 5 Feet 8 Inches or 1.84m
5. Applicant must have good moral conduct. Applicant must never have been convicted or charged in court or is on probation.
6. The organizer shall be the sole authority for interpretation of these rules and conditions. The decision of the organizer shall be final and binding.
7. In the event that any participants or winners is unable to fulfill her commitment any comply in regards to the rules and conditions the organizer shall have the right to withdraw the participant as one of the candidate or winner and will be asked to Pageant immediately.
8. The organizer shall not be responsible for any loss of valuable belongings by the contestant during the contest.
9. At all times, we will look into the safety of all contestants but we shall not be held liable ever for any incident occurring to the contestant during the contest should this be at their own negligence.
10. The organizer reserved the right to replace the participants with any other applicants of their choice at the **Manhunt India in National and International** final in the event of the disqualification or the release from participation of such finalist's applicant.
